INFORMATION ABOUT OUR USE OF COOKIES

Our website uses cookies to distinguish you from other users of our website. This helps us to provide you with a good experience when you browse our website and also allows us to improve our site. We will ask you for your consent to our use of cookies when you first access our website. If you do not consent, then you are treated as though you have blocked the use of cookies (see below). You may withdraw your consent by declining to accept the cookie policy when you visit our website.

A cookie is a small file of letters and numbers that we store on your browser or the hard drive of your computer, if you agree. Cookies contain information that is transferred to your computer's hard drive.

We use the following cookies:

Strictly necessary cookies. These are cookies that are required for the operation of our website. They include, for example, cookies that enable you to log into secure areas of our website, use a shopping cart or make use of e-billing services.

First Party	CFID	10950 Days (never)	Used to provide transaction support across multiple page requests commonly called a session
First Party	CFTOKEN	10950 Days (never)	Used to provide transaction support across multiple page requests commonly called a session
First Party	CookieStatus (name/duration may change)	10 Days	This cookie is used to save your acceptance of the use of cookies on our website. This is to prevent us from showing you the cookie message when you have already accepted it.
First Party	MobileFormat	10950 Days (never)	Used to determine whether or not to show the mobile format of the website.
First Party	MXP_TRACKINGID	10950 Days (never)	Used to anonymously track sessions within the website.
First Party	Slatwall-NPSID	End of Session	Used to provide transaction support across multiple page requests commonly called a session.
First Party	Slatwall-PSID	10950 Days (never)	Used to provide transaction support across multiple visits outside of a normal session. If this is used to re-attach a non-empty cart, then all personal information including account, addresses and payments are removed from the cart leaving just the items.
First Party	CGCOUNTRYCHECK	1000 Days	This cookie is used to save the acceptance that has shown you the country selector. This is to prevent us from showing you the message when you have already seen it.

Analytical/performance cookies. They allow us to recognise and count the number of visitors and to see how visitors move around our website when they are using it. This helps us to improve the way our website works, for example, by ensuring that users are finding what they are looking for easily.

Cookie Type	Name	Duration	Description
Third Party	__ga	730 Days	This helps us count how many people visit our website by tracking if you have visited before
Third Party	__gat_gtag_[Property-ID]	1 Minute	Used to limit requests (throttle requests rate)
Third Party	__gid	1 Day	Used to distinguish users

Functionality cookies. These are used to recognise you when you return to our website. This enables us to personalise our content for you, greet you by name and remember your preferences (for example, your choice of language or region).

Targeting cookies. These cookies record your visit to our website, the pages you have visited and the links you have followed. We will use this information to make our website and the advertising displayed on it more relevant to your interests. We may also share this information with third parties for this purpose.

First Party	MobileFormat	10950 Days	Used to determine whether or not to show the mobile format of the website
First Party	MXP_TRACKINGID	10950 Days (never)	Used to anonymously track sessions within the website.

Please note that third parties (including, for example, advertising networks and providers of external services like web traffic analysis services) may also use cookies, over which we have no control. These cookies are likely to be analytical/performance cookies or targeting cookies.

You can block cookies by activating the setting on your browser that allows you to refuse the setting of all, or some cookies. However, if you use your browser settings to block all cookies (including essential cookies) you may not be able to access all or parts of our site and our site may not function properly.

Except for essential cookies, all cookies will expire within their specified timeframe. Once expired, the browser will not send that particular cookie to the server with the page request, however this will also depend on the specific browser and the user's personal settings.
